

Generator Car Park Terms & Conditions

Parking Space licence terms. If your membership agreement with Generator New Zealand Limited (Generator) grants includes a parking space (or spaces), it or they will be provided on the following terms:

1. Generator grants you a licence to use the parking space(s) described in the reference schedule to your membership agreement (Parking Spaces).
2. Generator is entitled at any time, on giving not less than seven days written notice, to alter the location of any or all of the Parking Spaces to another or other parking spaces within the premises (Car Park).
3. The licence fee for the Parking Spaces is payable in accordance with your membership agreement.
4. You agree to use the Parking Spaces for parking cars and for no other purpose. You will not park more than one car per Parking Space.
5. You will be entitled to use the Parking Spaces 24 hours a day 7 days a week, unless otherwise advised by Generator (acting reasonably).
6. All cars are to be parked completely within the marked lines for the Parking Spaces and you will not park any car in a manner which may cause obstruction or nuisance to any other motor vehicle or any other user of the Car Park.
7. While using the Parking Spaces you may not:
 - a. carry out any repair or maintenance to any car;
 - b. wash any car otherwise than by specialist car valet services; or
 - c. spill or permit to be spilt oil or any other harmful substance, in any part of the Car Park. If you cause any damage or soiling to the Car Park then you will be required to reimburse Generator for the costs of making good the damage or soiling.
8. You are required to comply with any system which may be installed to regulate and control the movement of vehicles in and out of the Car Park. You are also required to comply with all rules and regulations notified to you concerning the security, safety and use of the Car Park.
9. You must pay for the costs of any access control cards/keys. You will also pay the costs for the call-out of Generator personnel due to the loss of any key, access card or other device provided for access to or from the Car Park or due to your use of any incorrect key or access card.
10. You may not assign, sublet, transfer or grant a licence of the Parking Spaces without Generator's consent.
11. Generator will not be responsible to you or any other person for any loss or damage sustained in respect of any car or its accessories or contents, however such damage or loss may be caused. You acknowledge that you use the Car Park and the Parking Spaces at your own risk in all respects.
12. You must reimburse Generator for all liabilities and expenses in connection with any damage to any property or any damage or loss of any kind sustained by Generator due to your use of the Car Park.
13. Generator may remove or re-position your cars in any case where an emergency requires use or uninterrupted access to the Parking Spaces. Generator will exercise reasonable care in doing so.
14. The licence to use the Parking Space continues for the term of your membership agreement, unless earlier terminated by either party.
15. On termination of this licence, you will promptly remove any motor vehicles belonging to you and under your control from the Car Park. If you fail to do so Generator may take steps to remove them.
